Estate upliftment

SBM will inform us the moment they have received this, and we will keep everyone informed as we progress.

Estate Security

We have had two incidents during August. First, a residential break-in took place on the Golden Mile side of the estate.

Second, we had a security and nuisance breach at a property that is being let out on short term rental terms. A bunch of young people caused a racket and we received numerous complaints - they were asked to vacate the property the next morning by 10h00. We are still investigating the circumstances under which the involved rental agent let out the property, in full collaboration with the owner.

Short-Term Letting of Property

We remind all owners who wish to let their properties on short term lease (for holiday home purposes) that this may only be done 1) after registration of the property as such, 2) written application to the HOA, and 3) completion of all relevant processes.
